



2018 Sunday Streets Amplified Sound Agreement

In addition to the expectations outlined in the Sunday Streets Programming Guidelines, all Sunday Streets activities using amplified sound must agree to the guidelines outlined below in order to participate in the event.

REQUIRED DOCUMENTS

- Submit a signed sound agreement to Sunday Streets staff prior to the event that includes:
 - o Contact information for an onsite representative who can make volume adjustments as needed throughout the day
 - o List of equipment to be amplified
- Obtain written approval from Sunday Streets Staff for use of a generator

EQUIPMENT GUIDELINES

- Amplification system not to exceed 700 watt output
- Generators not to exceed 5 gallons, must obtain written approval from Sunday Streets staff prior to event
 - o Our event permit allows for a limited number of generators. Therefore we encourage performers to do acoustic sets. Generator approvals are first come, first and are not guaranteed.
- Stages or other structures are prohibited

PLACEMENT/SETUP/BREAK-DOWN GUIDELINES

- **Load-In/Out:** Vehicles are not allowed on the route between 10:00am-4:00pm. If driving, please arrange for equipment drop-off and pickup to occur before or after the car-free event window.
- **Placement:** Use only your assigned location on the route – no self-relocating.
 - Each route has established locations for amplified sound approved in advance by the SF Entertainment Commission and local Police Station. Any amplified activity outside of these areas will be shut down.
- **Breakdown:** Bands must have all equipment and items broken down and off of the route by 3:45 p.m.

ONSITE CONDUCT POLICY

- Generate sound only during the stated hours of the event and sound permit (11:00am-4:00pm).
- Follow all placement and sound adjustment requests from Sunday Streets staff - Sunday Streets staff are managing the needs of multiple performers throughout the day and need your support in maintaining a respectful and fun environment for all.
- Set a good example by not consuming alcohol on the route during event times.

Any performer who violates these provisions will be taken off the Sunday Streets program roster and not invited to participate in the future.
