

# Sunday Streets 2019 Program Guidelines Amplified Sound Agreement

## About

Sunday Streets' mission is to:

- Create temporary open space and recreational opportunities in neighborhoods most lacking
- Encourage active living and healthy eating
- Foster community building
- Inspire people to think differently about their streets as public spaces

The Sunday Streets Program Guidelines were created to maintain public safety and the integrity of the program's mission. We thank you in advance for investing in San Francisco by participating at Sunday Streets and adhering to all of the Sunday Streets Program Guidelines.

Each route has established locations for amplified sound that is approved by the SF Entertainment Commission and neighborhood Police Station in advance of the event. During the event, we are busy balancing the needs of other performers, outreach booths, and neighbors, so we thank you in advance for getting us all your information early and adhering to the guidelines below so we can maintain a respectful and fun environment for all.

## **Equipment Guidelines**

- Amplification system not to exceed 700 watt output
- **Generators** not to exceed 5 gallons, must obtain written approval from Sunday Streets staff prior to event. Generator approvals are first come, first serve and are not guaranteed.
- **Stages** are prohibited unless you receive written approval from Sunday Streets staff prior to the event.

### Placement and Setup/Breakdown Guidelines

- Load-In/Out: Vehicles are not allowed on the route between 10:00am-4:00pm. If driving, please arrange for equipment drop-off and pickup to occur before or after.
- **Placement:** Use only your assigned location on the route. Any amplified activity outside of these areas will be shut down.
- **Breakdown**: Performers must have all equipment broken down and either on the sidewalk or parking lane by 3:45 p.m.

### **Onsite Conduct Policy**

- Generate sound only during the hours of the event (11:00am-4:00pm).
- Follow all placement and sound adjustment requests from Sunday Streets staff.
- No visible consumption of alcohol onsite or inappropriate behavior due to intoxication
