About

Sunday Streets is a program of the nonprofit Livable City, presented in partnership with SFMTA, SFDPH, and the City and County of San Francisco. Sunday Streets mission is to:

- Create temporary open space and recreational opportunities in neighborhoods most lacking
- Encourage active living and healthy eating
- Foster community building
- Inspire people to think differently about their streets as public spaces

The Sunday Streets Program Guidelines are created to maintain public safety and the integrity of the program's mission. We thank you in advance for investing in San Francisco by participating at Sunday Streets and adhering to all of the Sunday Streets Program Guidelines.

Vending Guidelines for Business On A Sunday Streets Route

Businesses are encouraged to do the following activities in the parking lane of their business and do not need proof of insurance or a seller's permit:

- Place outdoor seating and dining tables
- Host a "sidewalk sale" assuming the products meet the Merchandise and Food & Beverage Requirements below
- Put out a display table assuming the products meet the Merchandise and Food & Beverage Requirements below
- Host local, non-corporate vendors who meet the Sunday Streets Merchandise and Food & Beverage Requirements and Seller Permit & Insurance Requirements (hosting business assumes liability for ensuring all hosted vendors comply)

We still encourage you to register using the Exhibitor Application Portal to get promotional support for your activity.

Sunday Streets Market Square Vending Guidelines

On select routes, we host the Sunday Streets Market Square & Picnic Ground Program, presented in partnership with San Francisco's Department of Economic and Workforce Development which aims to support struggling commercial corridors and provide economic development opportunities for low-income communities who reside close by.

The program does this by creating a marketplace with built-in place making and professional vending infrastructure for neighborhood-based businesses, makers and entrepreneurs to sell at an affordable price during their neighborhood Sunday Streets.

In pursuit of these goals, Sunday Streets will only accept vendors who either have a brick and mortar business or production facility/studio or be a registered home-based business in the neighborhood. Vendors can get a waiver on this requirement if they are sponsored by a neighborhood-based business.

Merchandise Requirements

The sale of alcohol, tobacco, or cannabis products is strictly prohibited at Sunday Streets. Additionally, Sunday Streets will not accept goods vendors who sell products that are deemed to be in conflict with the promotion of sustainable transportation (car companies, fossil fuel companies, etc.).

Food & Beverage Requirements

Sunday Streets will not accept food or beverage vendors deemed to be in conflict with San Francisco DPH Healthy Eating Guidelines, including but not limited to sugary beverage food businesses.

All other food vendors agree to limit the sale of sugar-sweetened beverages and are encouraged to offer healthy, calorie-free alternatives. The sale of single-use plastic water bottles is strictly prohibited by all vendors.

Seller's Permit & Insurance Requirements

Vendors must provide a California State Seller's permit number and proof of insurance that meets the City and County of San Francisco requirements for their industry.

Vendor Liability

Vendor assumes all liability for staff and product while participating at Sunday Streets. Upon check-in, the vendor also assumes responsibility for all rental equipment and the cleanliness of their footprint.
